- Opportunities to secure funding for Te Tai Tokerau across all primary care services.
- Focus on care delivered in the community and consideration to the wider determinants of health and wellbeing.
- Ensure sustainability of General Practice and Primary Care Providers.
- Drive equitable health outcomes for Māori, Pacific and rural patients.
- Driving connection and closing the gap between secondary and primary care.
- Caring for whānau who are facing long wait times, cannot enrol with a GP or access afterhours services.

The Board received an update on behalf of the Appointments and Renumeration Advisory Committee. Following the resignation of Taco Kistemaker the Committee would like further time to seek a clinician with General Practice experience within Northland to join the Board. The Board approved.
