

Board Summary: 11 April 2025

Enhanced Capitation \$285M Over 3 Years Update

The CEO summarised the recent developments regarding enhanced capitation.

- CEO ensuring the voice of Te Tai Tokerau is well represented at PHO CEO meetings, and there is consensus that whatever model is agreed upon needs to take into consideration the challenges in Tai Tokerau.
- Proposal to be clarified and final framework still to be agreed. This is an opportunity for the Board to provide input.
- Important to consider how this will impact small rural general practices compared to larger general practices.
- \$60M is available under major enhanced capitation. Government is asking in exchange for the funds certain actions around increased access to be completed e.g. patients to be seen within 5 working days, and General Practices to be open two additional hours per week.
- Board members feedback on the GP workforce and concerns over financial viability for a small rural general practice has been noted. Broadway Health GP will be providing feedback to Minister Simeon Brown this afternoon at a ministerial meeting.

Health NZ Audit update

The CEO summarised the Health NZ | Te Whatu Ora auditors visit from 25 – 27 March 2025. Key discussion points included:

- Provisional verbal feedback was generally positive with some known areas to work on.
- Written report expected within six weeks which will be shared with the Board.

PHO Benchmark Comparisons

The CEO provided an overview of the recently published paper from retired accountant Murray Lilley, which was sent to Minister Simeon Brown. Key discussion points included:

- Limited partnership structures used by some PHOs hinder transparency, financial reporting lacks consistency making performance assessment difficult, increased share of Government funding, increased staffing costs.
- PHOs criticised in the paper have reacted swiftly.
- PHOs need to ensure they maintain their core business and as such Mahitahi Hauora has a moral responsibility to support its General Practices in Te Tai Tokerau.
